20+ Childcare Terms and Conditions

1. Until a Childcare Agreement is in place, the College has not formally agreed to pay any cost.
2. Learners must be aware of any contracts they are agreeing directly with the childcare provider and these are not the responsibility of College.
3. Learners must complete a childcare funding application form and provide copies of their income evidence with their application form. A childcare quote form can be either submitted with the childcare application form or submitted after provisional offering of childcare funding has been made.
4. In this application, any eligibility for the Free Early Education Entitlement (FEEE) must be used in the first instance.
5. The College sets maximum limits on charges it will pay. These are a maximum of £80 per day per child based on your actual timetable.
6. This application is for funding towards the cost of childcare for the parent/guardian **timetabled hours, term time only (with agreed retainer payments for specified holidays)**.
7. The parent/guardian will be responsible for any additional childcare costs outside the agreed amount such as late charges/fee increase/failure to attend and any sessions not previously agreed.
8. The parent/guardian must provide birth evidence for each child to be supported. This must be original birth certificate; copies will be retained by the College alongside application.
9. The terms and conditions are aligned to the Financial Support Procedures.
10. All application data is stored confidentially and retained for a period of seven years and is subject to Northern College Financial Regulations.
11. All information given within application is subject to GBGDPR and Data Protection regulations. Personal information and any supporting evidence will be used by the Financial Support Service for College/audit purposes.

Please be aware that the College does not pay for Bank Holidays.

Learners must not assume childcare will be awarded, and any costs incurred are the responsibility of the learner unless there is written agreement from the Learner Funds team that payment will be made.

What happens Next?

If your application is successful, you will receive a Childcare Agreement. This is a formal agreement that the College will pay for childcare

This is a three-part contract, which must be signed by the parent/guardian, the Childcare Provider and the College.

This agreement is a formal agreement that the College will fund childcare payments in line with agreed costs. The Childcare Agreement is a contract between the parent/guardian and the Childcare Provider. Therefore, it is the parent/guardian responsibility to adhere to the contracted terms and conditions.
